

Notice of Revised LDZ Gas Transportation Charges to Apply from 1st October 2008 for East of England, London, North West and West Midlands Distribution Networks

This notice confirms the LDZ gas transportation charges which will apply from 1st October 2008 for East of England, London, North West and West Midlands Distribution Networks. Notice is provided two months ahead of the implementation date, consistent with our Licence and Network Code obligations.

Changes to LDZ Gas Transportation Charges from 1st October 2008

Network	Change from existing charge level
East of England	+13.0%
London	-10.8%
North West	-0.5%
West Midlands	-8.3%
Weighted Average	+0.1%

These changes will be applied uniformly to the LDZ Customer charge rates.

The LDZ System capacity and commodity charge rates are impacted by the above changes and the change to the charging methodology described under consultation paper DNPC03. DNPC03 covered the move to a 95:5 LDZ System charge capacity:commodity methodology and the introduction of LDZ System capacity charges for transportation to interruptible sites.

The CSEP Administration Charge has been reduced to reflect the latest estimate of the administration cost per supply point.

Other administration charges and the Optional LDZ Charge are unchanged.

The reasons for the changes in charge levels were provided alongside the indicative charges published at the start of May.
