

Fast Reserve

Market Information for Tenders for June 2007

National Grid publishes this information, in order to inform potential participants for the Fast Reserve tender round for May 2007.

Fast Reserve Availability

Our indicative requirement for Fast Reserve in June 2007 is shown on a Settlement Period basis in Figure 1. This requirement covers weekdays, Saturdays, Sundays and Bank Holidays.

Fast Reserve Daily Requirement for May 2007

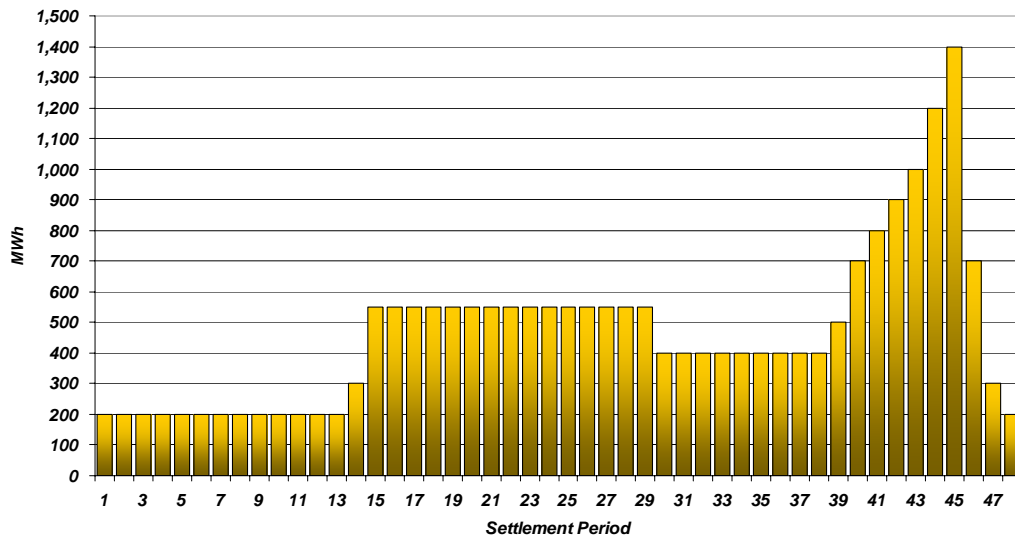

Figure 1 gives an indication of the times of day when Fast Reserve is most useful to National Grid. The actual amount of Fast Reserve "holding" varies from day to day, according to system conditions.

Fast Reserve Utilisation

Figure 2 shows the daily utilisation of Fast Reserve in the BM and elsewhere during March 2007 and April 2007. The BM information is based on the aggregate of Offers plus Bids accepted to provide Fast Reserve or an equivalent service.

Daily Accepted Fast Reserve Volume

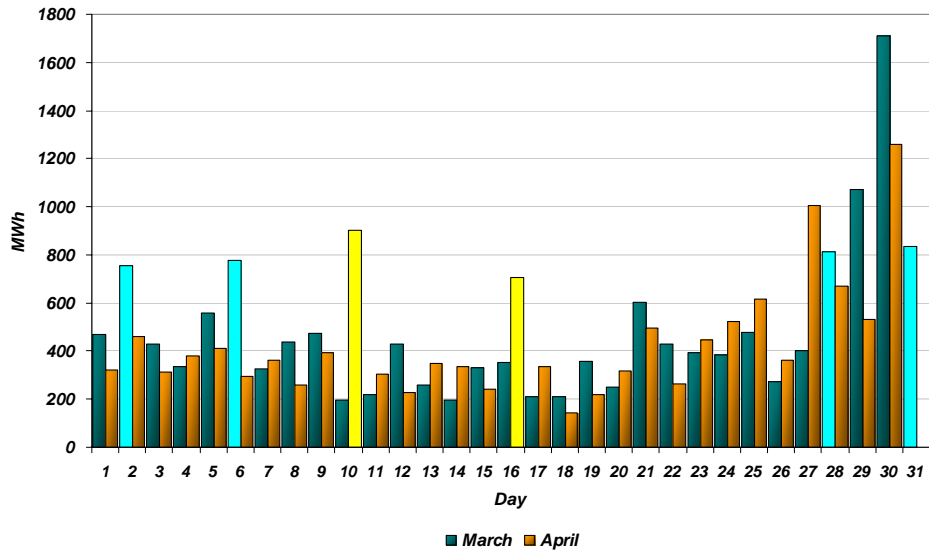

Figure 3 represents this data as total utilisation by Settlement Period across each month. This shows the daily profile of Fast Reserve utilisation.

Period Accepted Fast Reserve Volume

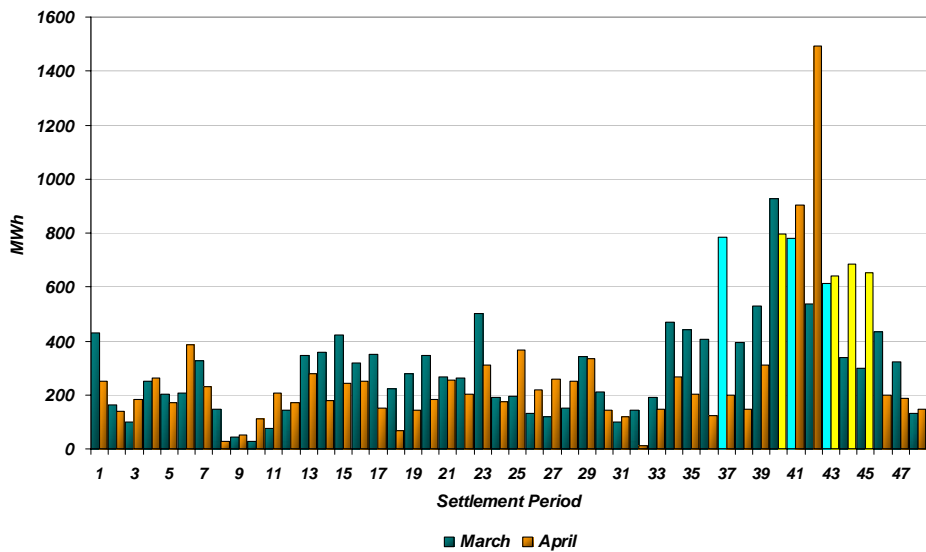

Figure 4 represents the same historical data, as an average utilisation price per Settlement Period for each month.

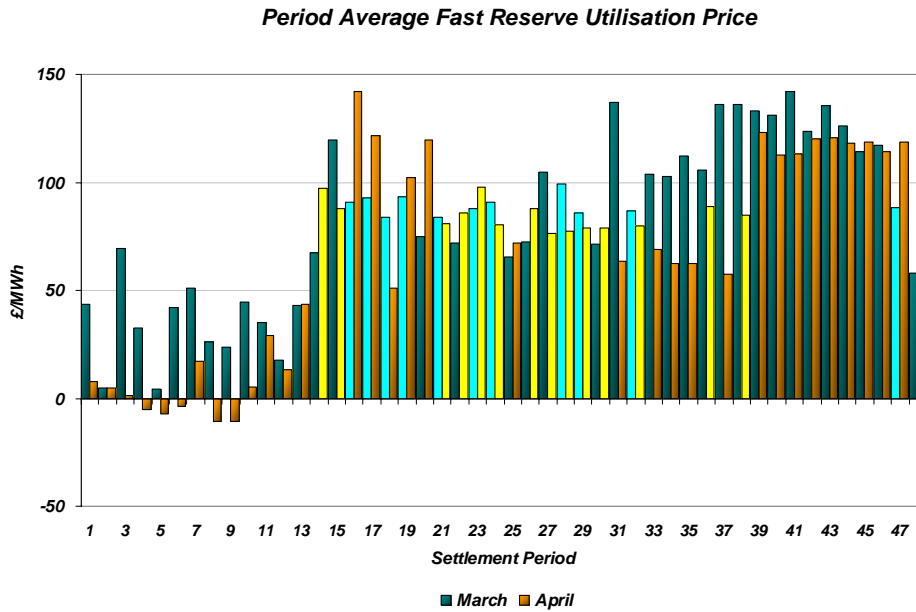

Finally, the same data is used in Figure 5, below, to show the profile of total Fast Reserve utilisation expenditure per Settlement Period for each month.

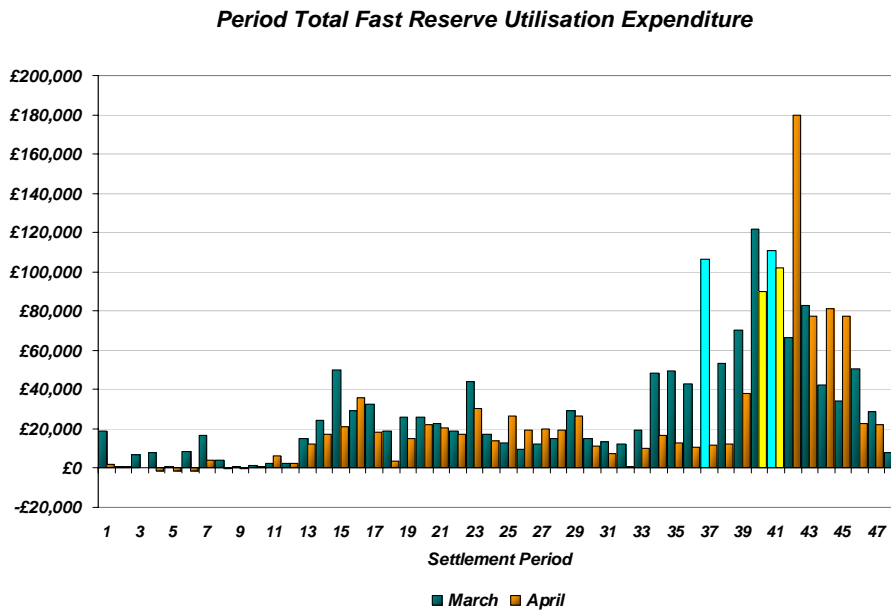
