- . Work will keep gas flowing until the end of the century
- · Part of programme to renew 27 miles of pipes across the city

National Grid will be upgrading gas mains in the Sanvey Gate area of Leicester to keep the gas flowing safely and reliably until the end of the century.

Work starts on Monday 19 October for two weeks to overhaul 87 metres of gas mains in Sanvey Gate. The existing iron mains will be replaced with tough, long-lasting plastic pipes that have a lifespan of at least 80 years.

For the second week of the work there will need to be lane closures in Burgess Street and Long Lane to keep engineers and road-users safe. If anyone has any queries about the work they can call National Grid's customer services team on 0800 0965678.

National Grid authorising engineer Mark Allsop said: "This vital work will ensure that local businesses and residents continue to enjoy a safe and reliable gas supply for decades to come. To keep everyone safe, lane closures will be necessary but every effort will be made to complete this work as quickly as possible."

The project is part of a year-long programme to renew more than 27 miles (44 kilometres) of pipes across Leicester.

The work is mainly taking place in residential roads. Among the areas where gas mains renewal is underway are Aylestone, Braunstone, Evington, Northfields, and the Gypsy Lane and Catherine Street areas.

Mr Allsop added: "National Grid is making a major investment in Leicester's gas mains to ensure local people continue to benefit from safe and reliable gas supplies for many years to come. This is essential work and we making every effort to minimise any disruption."

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We
 also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500
 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is
 consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other
 parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for
 consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors,
 gas metering activities and a liquefied natural gas (LNG) importation terminal all of which are now part of National Grid Ventures. National Grid
 Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
