- · Gas upgrade to start on Monday 27 July
- Road closure needed in Park Lane
- Work will secure local gas supplies for decades to come

A vital gas mains upgrade to keep gas flowing to homes and businesses in Nottingham for decades to come is due to start on Monday 27 July.

National Grid will be renewing nearly 500 metres of iron gas mains in Park Lane, from the junction with Arnold Road and Wallis Street. The existing iron mains will be replaced with tough, hardwearing plastic pipes that will last at least 80 years.

To carry out the work safely for all concerned Park Lane will be temporarily closed and a signed diversion route will be in place.

Among those streets affected by the work will be Avalon Close, Marsden Close, Selwyn Close, Kelfield Close, Gayhurst Road and Stoneycroft Road.

The work is expected to take six weeks, with the project taking place during the school summer holidays to reduce the disruption to the local community and the road network.

National Grid Authorising Engineer Paul Patrick said: "We are sorry for any inconvenience this work may cause but it is vital that we replace ageing gas mains so that local residents and businesses can continue to enjoy safe and reliable gas supplies for many years to come.

"It has been timed so that the bulk of the project will coincide with the school summer holidays to reduce the impact on traffic. We will be working on Saturdays to complete the work as soon as we can."

As part of the project it will be necessary to replace the service pipes that connect individual businesses and residential properties to the gas main. National Grid will contact all those who are affected to explain when this will take place and what is going to happen.

Businesses affected by the work may be eligible for compensation for loss of business under the Gas Regulations 1996. Businesses can find out more by going to www.nationalgrid.com/uk/gas.

Notes for editors

National Grid has two contracted organisations carrying out gas mains replacement work on its behalf. They are: tRIIO, a partnership between Skanska and Morrison Utility Services, in North London, East Anglia and the East of England and Balfour Beatty in the West Midlands and North West.

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
