

- Bid to beat last year's £4,000 charity total.

It's kettles on and ovens at the ready for National Grid staff in Hinckley and Leicester as they whip up a record-breaking, five-day feast of fundraising in aid of Macmillan Cancer Support.

National Grid is once again taking part in Macmillan's 'World's Biggest Coffee Morning' on Friday (25 September) – but instead of doing just the one day it's going for five.

As the charity marks 25 years of the landmark annual fundraiser, National Grid's staff in Leicestershire are going all-out to beat their £4,000 charity total raised last year.

Fundraising kicked off yesterday (Monday 21 September). There will be events in all departments at National Grid's Hinckley site and Leicester contact centre – including bakes-offs, raffles, sweets and savoury treats, home-made cakes and, of course, lots of coffee and tea. The team can also dress down and wear something green.

Macmillan Cancer Support is the chosen charity for National Grid; its generous employees have tirelessly championed the fundraiser for nearly two years.

Tanya Hutchinson said: "Macmillan is a charity close to our hearts as it was chosen by our employees. Sadly, many are touched by cancer or know someone dear whose life has been affected. Whenever we run our coffee mornings you can see the enjoyment it brings, as well as knowing we are doing something positive to help others."

There are currently 2.5 million people living with cancer and by 2020 almost one in two people will get cancer at some point in their lives.

The first Macmillan Coffee Morning was dreamed up by Joan Evett, who worked for Cancer Relief, and held in her local church. Since then it has become one of the UK's biggest charity events. Last year it raised a record breaking £25 million.

This year it's estimated that 220,000 people in the UK will hold a coffee morning - getting through six million cups of coffee and 12 million slices of cake.

National Grid already has a strong partnership with Macmillan Cancer Support. The company has raised more than £400,000 for Macmillan over the last 18 months and intends to meet its target to raise £500,000 for the charity in two years.

The money will be used to provide 2,500 'warmth without worry' emergency fuel grants to people who have cancer.

Macmillan improves the lives of people affected by cancer by providing practical, medical and financial support.

## Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

## National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
