- Temporary traffic management and relocation of bus stops required
- · Engineers will work extended hours and use minimal dig technology to reduce disruption

National Grid will be carring out essential gas mains replacement work in Wandsworth and Lambeth.

Engineers will be replacing ageing metal gas mains with new more durable pipes in Wandsworth Road and Nine Elms Lane. The work will help make sure local people continue to have safe and reliable gas supplies for cooking and heating.

Work is due to start on Monday November 10 and last for approximately six weeks.

Temporary traffic management systems and the relocation of some local bus stops will be required to ensure work is carried out safely and efficiently. However engineers will be working extended hours to make sure work is completed as swiftly as possible.

National Grid has also been discussing its work closely with Transport for London (TFL) and the local authorities to ensure it has minimal impact on the local community

Neil Jackson, National Grid project engineer, said: "Our work in the area will help ensure that local people continue to enjoy the safe and reliable gas supplies which help keep them warm throughout the autumn and winter months.

"We are doing all we can to deliver this essential work as smoothly as possible with minimal disruption to local people and road users."

National Grid is currently replacing aging metallic gas mains with tough new plastic pipes made of more durable material across the capital. Work is scheduled to take place in the area until summer 2015.

Innovative methods and effective technology is being used to minimise disruption and reduce noise levels. Wherever possible, new pipes are being inserted into old mains reducing the number of excavations needed and minismisinng any disruption for locals and road users..

The work should not result in any interruption to the local gas supply and the National Grid team shouldn't require access to any properties in the area.

The local community and surrounding business will be kept informed about the progress of the project by letter.

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We
 also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500
 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is
 consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other
 parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for
 consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors,
 gas metering activities and a liquefied natural gas (LNG) importation terminal all of which are now part of National Grid Ventures. National Grid
 Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
