National Grid works to keep homes warm in Holyport

- Essential gas mains work is taking place on Ascot Road near the M4 bridge

12 Nov 2014

Temporary traffic management will be in place

- Work is scheduled to begin on Thursday 20 November

National Grid is about to begin some essential gas main replacement work in Holyport's Ascot Road in the area around the M4 bridge.

Engineers will be replacing ageing metallic gas mains with tough new pipes made of more durable material.

Work is scheduled to start on Thursday November 20 and is due to be complete by the end of December 2014.

Temporary traffic lights will be going up in Ascot Road to enable the work to be carried out safely and efficiently.

Project Engineer Martin Jackman, said: "Our work in Holyport will help ensure that local people continue to enjoy safe and reliable gas supplies which help keep them warm throughout the autumn and winter months.

"The work will involve some complex engineering work and we'll need to dig excavations to complete it."

He added: "We've carefully planned the project and discussed it with the Royal Borough of Windsor and Maidenhead to ensure it's delivered as smoothly as possible with minimum disruption to locals and road users."

The work should not involve any interruptions to the gas supply and the team shouldn't require access to any properties in the area.

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
