- This document ("Bid Document") is submitted in response to and in accordance with the Auction Notice issued by National Grid Grain LNG Limited ("GLNG"), of which it forms a part.
- In this Bid Document, "GTCs", "AC" and "TUA" mean respectively the New Shipper General Terms and Conditions, the New Shipper Access Code and the Terminal User Agreement in the respective forms annexed to the Auction Notice. Terms used in this Bid Document and not defined herein or in the Auction Notice have the meanings given to them in such documents.

  - by way of confirmation of paragraph 6 above, no later than ten (10) Business Days after receipt by us of an engrossed version of the TUA, duly completed as specified in paragraph 7, we hereby undertake to procure that the same will be signed on our behalf by our duly authorised representative(s) and returned to GLNG, and we hereby unconditionally and irrevocably authorise GLNG to date such TUA once counter-signed by GLNG;
  - 10.2 notwithstanding paragraph 10.1 above, and with effect from the date of receipt of GLNG's notice that our Binding Bid has been accepted, we agree to be bound by the terms of our Services Agreement established pursuant to paragraph 7, which shall continue in full force and effect regardless of whether or not you or we subsequently sign the TUA pursuant to paragraph 10.1, on the basis that absence of a TUA signed by each of us will not in any way invalidate or make illegal or otherwise prejudice the Services Agreement and its enforceability by either of us, provided that we also acknowledge that a failure to return our signed TUA to GLNG within the timescale required may be treated by GLNG (at its sole discretion) as us disaffirming, disclaiming, repudiating or rejecting in whole or in part, or challenging the validity of, the Services Agreement, entitling GLNG to immediately terminate the Services Agreement; and
  - 10.3 we shall accompany our signed TUA with evidence that (i) the form of TUA signed by us is approved by us, and (ii) the individual(s) signing the TUA on our behalf is/are duly authorised to do so, in each case under and in accordance with the laws of the jurisdiction of our organisation and our constitutional documents.
- Our Binding Bid shall remain open for acceptance by GLNG in writing for forty-five (45) days from the deadline for submission of this Bid Document set out in the Auction Notice.
