We want to hear your thoughts on our proposals for LionLink (formerly known as EuroLink).

To support the UK's growing energy needs, National Grid Ventures (NGV) is bringing forward proposals for a new electricity link between Great Britain and the Netherlands.

This non-statutory consultation is supplementary to the previous non statutory consultation, which took place on Monday 24 October to Sunday 18 December 2022. All previous consultation responses have been logged and are being considered by the project team.

Following the 2022 non-statutory consultation, we have identified an alternative landfall site at Walberswick and an alternative underground onshore cable corridor to the north of Southwold. We welcome your thoughts on these alternative options.

The deadline for the submission of feedback is **Friday 3 November 2023**, when the consultation will close.

Please note, this feedback form is separated into two main sections:

- Section One (Q4 Q9) contains new questions that focus on the alternative landfall and onshore cable corridor options.
- Section Two (Q10 Q22) contains questions about the project as a whole and the other elements of the infrastructure (these questions were asked during the 2022 non-statutory consultation).
