### Challenged by our Stakeholder Group

In previous editions, we've talked about how we're building our business plans by listening to what you want from us, working with you to understand the choices you'd like us to make, and then making sure that our next submissions to Ofgem deliver what you need from us as efficiently as possible.

That's probably what you'd expect us to do anyway, but this time we're also being challenged by our independent Stakeholder Group, both on how we're engaging and how we're building our plans to reflect what we hear.

So far, the Group has challenged us to:

 Go further with our engagement, to engage in more detail with even more stakeholders

- 2. Increase our level of direct engagement with consumers
- Ensure that we can show the 'golden thread', which links our engagement and insights with what we include in our business plan

We've started to incorporate these challenges into the next phase of our engagement activities.

#### Building a regulatory framework to meet our stakeholders' needs

As well as making sure the content of our business plans delivers what our stakeholders need from us, we also need to make sure that the regulatory framework within which we operate is fit for purpose for all parties involved.

Between September and November this year, Ofgem has hosted more than 20 workshops in London and Glasgow, covering how they will assess our costs for the RIIO-T2 period (2021-26), what incentives should exist for networks to deliver better outputs, and how networks should be encouraged to innovate and work together as a 'whole system', plus financial issues such as the cost of equity and the cost of debt for RIIO-T2.



These groups include the three transmission owners in Great Britain (us, Scottish Power and SSE), and stakeholders such as Citizens Advice, Sustainability First and the Renewable Energy Association.

Following these workshops, Ofgem will be consulting on the transmission regulatory framework in December, giving all stakeholders an opportunity to have their say.

Throughout this process, we're making sure that Ofgem is aware of our own stakeholders' priorities.

### Shaping our plans on network resilience

We held a stakeholder workshop on 23 October 2018 in Canary Wharf, London to discuss how we should continue to protect our network against external threats.



Key headlines from the workshop were:

- The need for a resilient electricity network is likely to increase in the future
- Cyber attacks are seen by many stakeholders' as the biggest short-term threat, and climate change could have the greatest longer-term impact
- Our current approach to physical security is supported
- For cyber resilience and black start recovery, we need to be joined up with the right organisations to ensure a coordinated approach
- Our approach to extreme weather resilience needs to be flexible, forward looking, and adapt to likely future changes

We are incorporating what we heard at the workshop with feedback from other engagement activities and (with input from our Stakeholder Group and Ofgem's Challenge Group) are using this to develop our RIIO-T2 business plans.
