- Notice is hereby given that National Grid Electricity Transmission plc of 1 3 Strand, London, WC2N 5EH (the "Applicant") intends to apply to the Secretary of State for Business, Energy and Industrial Strategy for a Development Consent Order ("DCO") under Section 37 of the Planning Act 2008 (the "Act") to authorise the construction and operation of the Yorkshire Green Energy Enablement (GREEN) Project (the "Project").
- The Project will comprise approximately 7km of new overhead lines, a number of cable sealing end compounds, underground cables and two new substations (one near Overton and one near Monk Fryston), to link two existing overhead lines and to reinforce the system to increase the capacity of the network in the Yorkshire area. It will also include additional improvements and strengthening works to existing infrastructure, including existing overhead lines (conductors), fittings and pylons, utility diversions, connections and drainage works. The Project is sited within Yorkshire, routed from the most northerly components of the Project located approximately 1.5km north-east of the village of Shipton-by-Beningbrough and approximately 10km north-west of York city centre, to the most southerly components at Monk Fryston Substation, located to the east of the A1 and immediately south of the A63. The Project will also be routed via the Tadcaster area, located approximately 3km south-west of Tadcaster and to the north-east of the A64/A659 junction, where new components of infrastructure will also be proposed.
- 3. The proposed DCO would authorise the following works:
 - Creating a double tee arrangement at the existing 400kV Norton to Osbaldwick (2TW/YR) overhead line route by installing a replacement pylon and two cable sealing end compounds with a section of connecting

- underground cable (approximately 0.2km) to the new 400kV overhead line to the new Overton Substation.
- Approximately 2.8km of new overhead line route (400kV) between the 400kV Norton to Osbaldwick (2TW/YR) overhead line and the new Overton Substation North-West of York.
- One new substation, called Overton Substation, sited to the north of the 275kV Poppleton to Monk Fryston (XC/XCP) overhead line route.
- Approximately 3.6km (2.1km for one route, and 1.5km for the other) of two new overhead lines (two separate lines of pylons) between the existing 275kV Poppleton to Monk Fryston (XC/XCP) overhead line route and the new Overton Substation.
- Replacement and re-alignment of approximately 2.8km of the existing XCP overhead line route from near Overton Wood to south of Moor Monkton.
- New conductors and fittings, surface foundation repair, pylon strengthening, and potential replacement of pylons, on the 275kV Monk Fryston to Poppleton (XC/XCP) overhead line routes between south of Moor Monkton and close to the new substation at Monk Fryston.
- Creating a double tee arrangement at the Tadcaster Tee by installing two sealing end compounds and a section of connecting underground cable (approximately 0.35km) constructed from the 275kV Monk Fryston to Poppleton (XC) overhead line route, to the 275kV Tadcaster Tee to Knaresborough (XD/PHG) overhead line route.
- Reconfiguration of the existing 275kV XD/PHG overhead line connecting to the XC overhead line at the Tadcaster Tee to enable a double tee arrangement. Work includes a replacement XD pylon near to the junction with the XC route.
- Reconfiguration (including a new section of overhead line, approximately
 1.6km) of the existing 275kV Poppleton to Monk Fryston (XC/XCP)

overhead line route to connect into the new Monk Fryston Substation, and section of underground cable (approximately 0.6km) to connect to the new Monk Fryston Substation.

- One new substation located next to, and connecting into, the existing Monk Fryston Substation.
- Reconfiguration, including removal of approximately 0.375km of existing 4YS 400kV overhead line. Approximately 0.25km of new 4YS 400kV overhead line will be built to connect into the new Monk Fryston Substation.
- Installation of a new gantry, cable sealing ends (removing the existing gantry), new circuit breaker, isolator, and short section of underground cable (approximately 0.1km) at Osbaldwick Substation.
- Protection and control changes at Norton, Osbaldwick, Poppleton, Knaresborough, Monk Fryston and Eggborough Substations including new and altered electronic equipment (substantially inside substation buildings), and associated wiring and cabling.
- Utility diversions and connections along the route of the new and existing overhead lines and at substations and cable sealing end compounds.
- 4. The Project will include other required works, for example, temporary access roads, highway works, temporary works compounds, work sites and ancillary works. The Project will also include utility diversions and drainage works.
- 5. The Project will seek authorisation for the compulsory acquisition of land and interests in and rights over land, overriding easements and other rights, the temporary use of land, and other ancillary powers.
- The Project is an Environmental Impact Assessment ("EIA") development, as defined by The Infrastructure Planning (EIA) Regulations 2017. An Environmental Statement will therefore be submitted as part of the application, which will contain information about the environmental effects of the Project.
