National Grid Electricity Transmission is consulting on proposals to extend the existing 400 kV Creyke Beck substation in Cottingham, north of Hull, and build a new 400 kV substation approximately 700m northwest of the existing substation.

Overview

The way we generate electricity in the UK is changing rapidly, and we are transitioning to cheaper, cleaner and more secure forms of energy like new offshore windfarms. We need to make changes to the network of overhead lines, pylons, cables and other infrastructure that transports electricity around the country, so that everyone has access to the clean electricity from these new renewable sources.

Our proposed substation works are needed to connect new offshore wind and interconnectors to the electricity transmission network in the area and reinforce the local network.

Our proposals are part of **The Great Grid Upgrade** – the largest overhaul of the grid in generations. The substation works in the Creyke Beck area will support the UK's net zero target.



