# 'Grim' waits for mental health

More on list than live in

large town

The number of people in the region waiting more than a year for NHS mental health treatment is larger than the population of Long Stratton, shocking new figures have shown.

Some 5,600 people have been on waiting lists for more than 12 months to be seen by staff at the Norfolk and Suffolk NHS Foundation Trust (NSFT), with more than 4,000 of them yet to even have their needs assessed.

The figures, which are rising, raise fresh fears over the provision of mental health care in the region and cast doubt on claims the organisation is making rapid improvements. The NSFT has struggled with poor performance ever since it was established in 2012.

It has been placed in special

measures four times since then and has been described as the worst mental health trust in the country.

Caroline Aldridge, right, whose son Tim died while on an NSFT waiting list, said the figures showed "a grim and shocking truth" and many were suffering while they waited for vital treatment.

National Grid Electricity Transmission is holding a Stage 1 (non-statutory) public consultation to hear your views on our early proposals for Eastern Green Link 3 (EGL 3) and Eastern Green Link 4 (EGL 4), two new high voltage electricity links between Scotland and England.

The links would transport enough clean energy from Scotland to power up to four million homes in the Midlands and South of England, playing an important role in building a more secure and resilient future energy system and the decarbonisation of the UK electricity system.

Both links would be primarily offshore, with proposed onshore infrastructure in England located within the districts of East Lindsey, Boston, South Holland, and King's Lynn and West Norfolk. This onshore infrastructure includes underground cables, converter stations, a direct current switching station and a substation.

The non-statutory consultation will begin Tuesday 23 April 2024 and run for eight weeks until Monday 17 June 2024.
