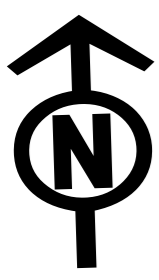
1. Environmental Implications of Change (EIC) – Section 1 Anderby Creek Landfall to Candlesby

1.1 Introduction

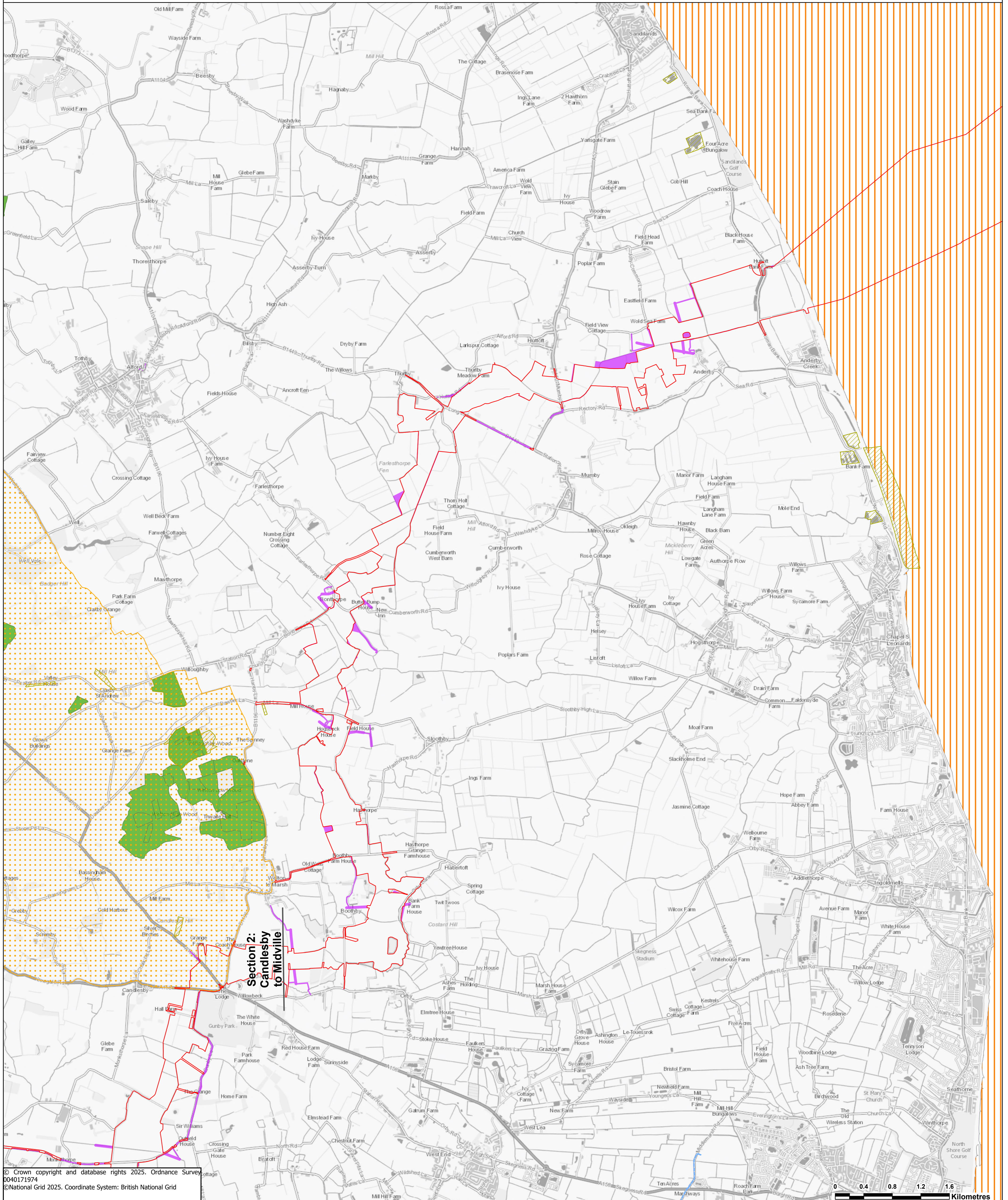
- 1.1.1 This Environmental Implications of Change (EIC) report has been prepared to support the targeted consultation for Eastern Green Link 3 (EGL 3) and Eastern Green Link 4 (EGL 4) (the 'Projects'). The report outlines the changes made to the Order Limits of the 'Projects', since Stage 2 consultation held between 13 May and 25 June 2025 (herein referred to as the 'Draft Order Limits from Stage 2 consultation 2025'). This report makes specific reference to Section 1 Anderby Creek landfall to Candlesby.
- 1.1.2 Separate EIC reports covering Sections 2 to 7 of the Projects are available on the project website¹.
- 1.1.3 This report assesses whether the proposed changes introduce any material change to environmental effects in comparison with what has been the subject of previous consultations, specifically the effects presented within the Preliminary Environmental Information Report (PEIR) prepared for the Projects in May 2025 and presented at Stage 2 consultation (**Ref 1-1**).
- 1.1.4 **Section 1.3** describes the methodology used for this assessment.
- 1.1.5 This EIC report should be read alongside the associated Section 1 Anderby Creek landfall to Candlesby targeted consultation leaflet. This report can also be viewed on the Project website. There is no formal requirement to prepare a PEIR or an addendum to the PEIR to support this consultation (**Ref 1-2**).
- 1.1.6 **Image 1** presents the Draft Order Limits from Stage 2 consultation 2025 and the proposed changes that have since been incorporated into the Order Limits (Additional Areas for Targeted Consultation 2026) for Section 1 Anderby Creek Landfall to Candlesby.
- 1.1.7 Maps showing all of the changes in detail for Section 1 Anderby Creek Landfall to Candlesby are included in **Appendix A**. These maps contain references for each individual change (for example Change 1-1) which correspond to detailed descriptions provided in **Appendix B**.

1.2 Description of the Proposed Changes Since Stage 2 Consultation 2025

1.2.1 Since the Stage 2 consultation held between 13 May and 25 June 2025, the design of the Projects has changed. Though the Projects taken as a whole have not changed significantly, we are proposing some changes to the Draft Order Limits from Stage 2 consultation 2025 within Section 1 Anderby Creek Landfall to Candlesby, which are needed to support the safe construction and operation of the project. This includes additional land required for:

- Diversions of existing utilities - some temporary and permanent works to raise the height of existing overhead lines by 10%, to allow for access of tall vehicles to facilitate construction, and some works to move existing overhead lines underground as a more permanent solution.
- Minor adjustments to the cable alignment; cable realignment will not divert from the cable corridor construction Limits of Deviation (LOD).
- Drainage infrastructure.
- The use and extension of existing access tracks to facilitate construction and future maintenance.
- Installation of temporary access tracks and haul roads.
- Road works – in some places highway widening may be required to accommodate general construction traffic, while in others widening or clearance will be needed to facilitate the safe passage of Abnormal Indivisible Loads (AILs). In addition, some areas of land are needed for new or improved bell mouths, and visibility splays that would require the removal of some vegetation.

1.2.2 A detailed list of all changes to the Draft Order Limits from Stage 2 consultation 2025 within Section 1 Anderby Creek Landfall to Candlesby is included in **Appendix B**.

1.3 Environmental Implications of Change Approach and Method

1.3.1 The methodology to assess the environmental implications of change has been developed with reference to the guidance issued by the Department for Levelling Up, Housing and Communities (DLUHC) regarding *Planning Act 2008: Preapplication stage for Nationally Significant Infrastructure Projects (Ref 1-1)*.

1.3.2 In particular, the methodology considers the following criteria:

1.3.3 *Only where the project taken as a whole changes very significantly, and to such a large degree that what is being taken forward is fundamentally different from what was previously consulted on, should re-consultation on the proposed application as a whole be considered.*

1.3.4 *In understanding whether there has been a material and substantial change, applicants should take into account the following guiding factors:*

- *the degree of change as compared to the proposals previously consulted upon as a whole;*
- *the number of materially worse environmental effects as compared to what has been the subject of previous consultations; and*
- *the level of public interest, and the likelihood that such interest would merit further consideration in the context of that change.*

1.3.5 *For any material change to a part of the proposed application where the project as a whole is not fundamentally changed, for example in the case of linear aspects where new information leads to a new alignment for a particular section of the proposal, a bespoke and targeted approach to further consultation can be adopted, which can address the specific consultation obligations arising proportionately.*

1.3.6 The methodology used in this EIC to assess whether there has been a material and substantial change has followed the same approach for assessment of significance that was adopted in the PEIR (Volume 1, Part 1, Chapter 5: PEIR Approach and Methodology (**Ref 1-3**)).

1.3.7 We have reviewed the proposed changes included in the current Order Limits against the Draft Order Limits from Stage 2 consultation 2025, presented within the PEIR and at Stage 2 consultation, and evaluated whether the changes would lead to any of the following:

- The introduction of new adverse environmental effects, that were not anticipated or assessed within the PEIR;
- Adverse effects previously identified as not significant within the PEIR which could now be significant; or
- Previously identified significant adverse effects increasing in magnitude or changing in nature.

1.3.8 We have applied the same methodologies and principles set out in the PEIR based on the information available and recognising that the Projects are the subject of ongoing consultation and environmental surveys.

1.3.9 This EIC focuses on the likely significant environmental effects during the construction and operation phases that would be material to a decision to consent the Projects.

1.3.10 There are generally no anticipated changes to decommissioning to those set out in the original PEIR. Therefore, decommissioning is not discussed further in this EIC.

1.3.11 The effects noted in this EIC take into account any mitigation measures that were identified within the original PEIR, that would avoid or reduce significant environmental effects from the construction and operation phases of the Projects.

1.3.12 Volume 1, Part 1, Chapter 4: Description of the Projects of the PEIR includes a number of project assumptions regarding the construction programme, working methods (**Ref 1-4**). These assumptions all still apply (unless specified otherwise in the paragraphs that follow) and have been used when assessing the changes presented within this EIC.

1.3.13 For the purposes of this assessment, where optionality exists in the design of the changes, the 'reasonable worst-case' out of each of the potential work options has been assessed for each technical topic.

1.4 Environmental Implications of Change

- 1.4.1 We have undertaken this review against each of the technical topics covered by the PEIR, with respect to Section 1 Anderby Creek landfall to Candlesby. These technical topics are Agriculture and Soils; Air Quality; Biodiversity; Geology and Hydrogeology; Health and Wellbeing; Cultural Heritage; Water Environment; Landscape and Visual Amenity; Noise and Vibration; Socio-economics, Recreation and Tourism; and Traffic and Transport. Greenhouse Gas has not been included within this report, as the proposed changes to the Order Limits are not anticipated to lead to any new environmental effects, or to alter the significance of any potential environmental effects. Cumulative Effects have also not been included in this report, as no assessment of cumulative effects was presented within the PEIR.
- 1.4.2 The assessment undertaken as part of this EIC has identified that for a number of the environmental topics, the environmental effects would likely be different to those presented within the original PEIR submitted at Stage 2 consultation. In these cases, the conclusions have been summarised and are presented in **Table 1-1**.

Table 1-1 Environmental implications of the proposed changes when compared to the preliminary assessment presented in the PEIR

Environmental Topic	Comments / observations / identified environmental implications of the proposed change when compared to the preliminary assessment presented in the PEIR
Agriculture and Soils	<p>The provisional Agricultural Land Classification (ALC) grade and Soil Associations presented at Stage 2 consultation in 2025 remain representative of those identified for the changes discussed in this document. This includes Provisional ALC Grade 2 and Grade 3 land, which are assumed, as a worst case, to comprise Best and Most Versatile (BMV) land.</p> <p>In general, where proposed changes impact agricultural land, they are small scale (of 86 changes, 12 are between 1 ha and 2 ha, one is 7.6 ha), located on field margins or in corners of arable fields. Therefore, they would not cause a change to the nature, magnitude or significance of agriculture and soil effects compared to the design and information outlined in the PEIR presented at Stage 2 consultation in 2025.</p> <p>For reference, the assessment presented in Chapter 11 of the PEIR for Agriculture and Soils receptors was:</p> <ul style="list-style-type: none"> • Impact of construction: not significant for Agricultural Land Holdings; significant for Soil Function and Agricultural Land Quality. • Impact of operation and maintenance was, for all receptors, not significant. <p>Some changes affect fields which were previously not impacted by the Order Limits; however, given the type of works and size of the areas affected in comparison to the project as a whole, within the assessment of impact made at PEIR (summarised above), these are not expected to introduce any new significant effects:</p> <p>1-4 (1.7 ha)</p>

- 1-7 (1.6 ha)
- 1-10 (7.6 ha)
- 1-63 (0.9 ha)
- 1-64 (1.5 ha)
- 1-84 (1.1 ha)

However, it is anticipated that the following changes may lead to the introduction of new environmental effects when compared to the PEIR:

Change 1-9 (1.8 ha) is proposed for utility diversions and land drainage and affects a field which did not fall within the draft Order Limits at the Stage 2 consultation. On the south-eastern corner of this change, the area crosses a woodland which is mapped as being under a Woodland Grant Scheme 3 (England) and enters an area of land which aerial imagery indicates may be a caravan/holiday park. Depending on the works required in this area, there may be additional impacts in terms of disturbance to the woodland, requiring compensation with respect to the Woodland Grant Scheme and/or replacement woodland; and in terms of impact on the caravan/holiday business. Works will be undertaken in such a way that impacts to these receptors are minimised.

Change 1-41 (1.4 ha) affects a field which did not fall within the draft Order Limits at Stage 2 consultation. These changes relate to utility diversions where the draft Order Limits have been extended to accommodate works to the existing utilities as well as to incorporate existing access to the utilities. The existing utilities cross over a farmyard and the access to these also pass through the farmyard. Works would therefore be undertaken in such a way as to have minimal impact on the business.

Changes 1-54 (1.4 ha) and 1-57 (1.3 ha) affect fields (1-54 and 1-57) and an area indicated by aerial imagery to be garden to Hogsbeck House or grassland (1-54), which did not fall within the draft Order Limits at Stage 2 consultation. The changes in this area relate to works to existing utilities and access for this and would not introduce any new significant effects.

Air Quality

There would be no change to the nature, magnitude, or significance of the air quality effects resulting from the proposed changes when compared with the effects described in the PEIR submitted at Stage 2 consultation in 2025. The proposed changes are not expected to introduce any new or materially different air quality effects or alter the conclusions in the PEIR regarding their significance. Monitoring and mitigation measures identified in the design and PEIR would remain appropriate to manage any air quality impacts associated with the Projects.

Biodiversity

Change 1-10 introduces an area of approximately 7.6ha into the draft Order Limits from Stage 2 consultation that has not been subject to a full ecological walkover survey. However, from an assessment of aerial imagery and desk study data, the area comprises predominantly agricultural fields bordered by drainage ditches and/or hedgerows. This habitat composition is comparable to the wider surveyed area across the Projects. With embedded mitigation, which includes pre-

commencement walkover surveys, it is anticipated that impacts can be reasonably avoided or mitigated and significant effects are unlikely.

Ecological surveys have not yet been undertaken for several areas introduced in relation to utility diversions; for example, Changes 1-4, 1-9 and 1-57; and highway improvement works, for example Changes 1-28 and 1-31. However, works are anticipated to be localised and small-scale. Whilst a full impact assessment is required, it is anticipated that significant effects can be reasonably avoided or mitigated by standard best practice, protected species licensing and/or existing environmental mitigation measures.

All other proposed changes are relatively small and discrete areas.

Overall, it is anticipated that there would be no change to the nature, magnitude, or significance of biodiversity effects as a result of the proposed changes, when compared to the design and PEIR presented at Stage 2 consultation in 2025.

Geology and Hydrogeology	There would be no change to the nature, magnitude, or significance of geology or hydrogeology effects as a result of the proposed changes when compared to the design and PEIR presented at Stage 2 consultation in 2025.
Health and Wellbeing	There would be no change to the nature, magnitude, or significance of health and wellbeing effects as a result of the proposed changes when compared to the design and PEIR presented at Stage 2 consultation in 2025.
Cultural Heritage	<p>It is anticipated that the following changes may lead to the introduction of new environmental effects when compared to the PEIR:</p> <ul style="list-style-type: none">• Change 1-41 – utility diversions and land drainage would cross through the recorded location of the deserted medieval settlement of Bonthorpe (MLI84121). This would not result in any change to the assessment presented in the PEIR, resulting in a minor adverse significance of effect.• Change 1-46 – land drainage would cross through the recorded location of a possible western extension to the scheduled Butterbump Barrow Cemetery (MLI42930). The Historic Environment Record (HER) defines this asset as the cropmarks of 11 ring ditches which may represent further barrows associated with the scheduled barrow cemetery (NHLE 1003615). Although the ring ditches have not been investigated on the ground, the asset is considered to have archaeological interest as they have the potential to further inform on Bronze Age funerary and ritual practices and their association with the surrounding prehistoric landscape. Although not designated, as an asset associated with a scheduled monument the site is considered to be high value. With mitigation in place, this would cause a low magnitude of impact, resulting in a significance of effect of moderate adverse. This could potentially be significant.• Change 1-57 – a utility diversion would partially cross through an area of medieval earthwork ridge and furrow (MLI84146), though impacts may be avoided if works are restricted to land

south of drainage channel that runs along the north boundary of the field. The remains are considered to be of low heritage value for their archaeological interest to provide evidence on agricultural practices and land use in the medieval period. The utility diversion could impact the earthworks. If so, the magnitude of impact upon the asset is low. On an asset of low value, this results in a significance of effect of minor adverse.

- Change 1-64 – a utility diversion and land drainage would cross through an area of medieval earthwork ridge and furrow (MLI97834). The remains are considered to be of low heritage value for their archaeological interest to provide evidence on agricultural practices and land use in the medieval period. The utility diversion and drainage would impact the earthworks, resulting in a magnitude of impact of low. On an asset of low value, this results in a significance of effect of minor adverse

Beyond those described above, there would be no further change to the nature, magnitude or significance of cultural heritage effects as a result of the proposed changes, when compared to the design and PEIR presented at Stage 2 consultation in 2025.

Water Environment	There would be no change to the nature, magnitude or significance of water environment effects as a result of the proposed changes, when compared to the design and PEIR presented at Stage 2 consultation in 2025. The proposed control and management measures detailed in the PEIR would be effective in mitigating any effects associated with the proposed changes.
Landscape and Visual Amenity	<p>There would be no change to the nature, magnitude or significance of landscape and visual amenity effects as a result of the proposed changes, when compared to the design and PEIR presented at Stage 2 consultation in 2025. This is either due to the changes being considered minor or be temporary in nature, in accordance with the assumptions made within this review.</p> <p>A large proportion of changes include for the provision of or adjustments to Maintenance Access which is permanent (see Appendix A and Appendix B). While individually considered minor in nature, these will be considered collectively with regards to landscape character and assessed at Environmental Statement (ES) Stage with any vegetation removal requirements considered. At this stage, it is considered that, collectively, these changes may introduce new adverse effects when compared to the PEIR.</p>
Noise and Vibration	<p>There would be no change to the nature, magnitude, or significance of the noise and vibration effects resulting from the proposed changes when compared with the effects described in the PEIR submitted at Stage 2 consultation in 2025. The proposed changes are not expected to introduce any new or materially different noise or vibration effects or alter the conclusions in the PEIR regarding their significance.</p> <p>Monitoring and mitigation measures identified in the design and PEIR would remain appropriate to manage any noise and vibration impacts associated with the Project.</p>

Socio-economics, Recreation and Tourism	There would be no change to the nature, magnitude, or significance of socio-economics, recreation and tourism effects as a result of the proposed changes when compared to the design and PEIR presented at Stage 2 consultation in 2025.
Traffic and Transport	There would be no changes to the nature, type or significance of traffic and transport effects as a result of the proposed changes, when compared to the design and PEIR presented at Stage 2 consultation in 2025.

1.5 Conclusion

- 1.5.1 It is anticipated that the proposed changes would lead to the introduction of some new adverse environmental effects, that were not anticipated or assessed within the PEIR and presented at Stage 2 consultation in 2025. In the limited cases described in **Table 1-1**, these effects may be significant. These adverse environmental effects would be confined to a small number of receptors located within, or directly adjacent to, areas where the Order Limits have been expanded.
- 1.5.2 It is considered that the changes do not materially alter the conclusions of the PEIR as a whole.
- 1.5.3 A targeted approach to further consultation is therefore appropriate and is taking place between 09 April 2026 and 11 May 2026, the purpose of which is to provide an opportunity for stakeholders and members of the public to understand the changes and share their views.
- 1.5.4 If the proposed changes are taken forward, the baseline information (and environmental surveys) and assessment associated with these changes would be provided in the ES.

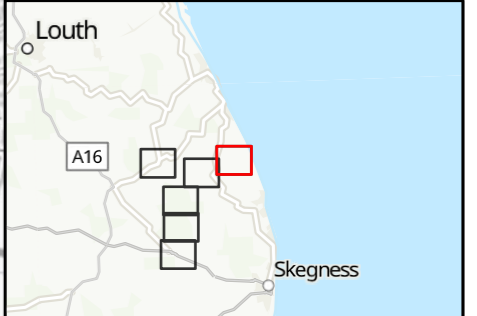
