In the western end of the section where the two roads and rail line converge the area is wooded in which are Boston Lodge Cottages. Outwith these areas the land is predominantly open, presumed agricultural with a number of small drainage channels along field boundaries

Where Penrhyndeudraeth encroaches into the Study Area a rail station, a street of housing along the road between Penrhyndeudraeth and Minffordd, and a vicarage are noted. To the south of the rail line on the boundary of the estuary are two properties 'craig-y-don' and 'ynysfawr' are noted. Between Minffordd and Penrhyndeudraeth on the linking road lie two large buildings, 'Hendre Hall on the south of the road and the 'Ffestiniog Union Workhouse' on the north. Minffordd in the western portion of the section is built around a junction with the main road and includes a number of residential properties, and a railway station. The station lies at the confluence of the Cambrian Railway from the east and the Ffestiniog Railway entering the town from the north east. The Ffestiniog Railway continues west through Minffordd and the Cambrian continues to the north west were it enters wide cuttings before passing Garth Quarry to its immediate north within the boundary of the Study Area. The area around Minffordd notes a number of separa
