## Planning and Advanced Reservation of Capacity Agreement (PARCA)

### NOTICE: PARCA APPLICATION - ALLOCATION OF NTS EXIT CAPACITY

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, we hereby publish this notice to all interested parties.

On the 25<sup>th</sup> April 2016, we issued a notice, with respect to a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application ('Notice: Opening of a PARCA Window'). The PARCA application was for National Transmission System ("NTS") exit capacity between 26,040,000kWh/d and 40,920,00kWh/d in North East Yorkshire and Lincolnshire (Region 3 as defined in Gas Ten Year Statement<sup>1</sup>). The indicative capacity Reservation Date specified at the time was 18<sup>th</sup> October 2016, with the indicative capacity Registration Date of 1<sup>st</sup> April 2019.

On 12<sup>th</sup> October 2016, we issued an informal notice ('Keadby 2 PARCA ExCS Informal Notice (including Exit Substitution & Baseline Revision') which outlined our proposals to meet an increased capacity requirement of 42,518,000kWh/d with an indicative capacity Registration Date of 1<sup>st</sup> April, 2019.

On 31<sup>st</sup> May 2017, we issued a notice to confirm the PARCA Application had progressed to Phase 2, and a reduced quantity of 39,776,149kWh/d of NTS exit capacity had reserved. The indicative Registration Date was 1<sup>st</sup> April 2020.

On 9<sup>th</sup> March 2020, we issued a notice to advise that the Registration Date has been revised following a request from the Reservation Party.

On 29<sup>th</sup> April 2020, we issued a notice to advise that the Registration Date has been revised following a request from the Reservation Party.

On 1<sup>st</sup> October 2020, we issued a notice to advise that the Registration Date has been revised following a request from the Reservation Party as follows;

#### From 1<sup>st</sup> November 2021
