# Archaeology surveys and ground investigation works update

## National Grid will be undertaking a range of archaeology surveys and ground investigation works in Kent from August 2026. This update explains what these works involve and what you can expect to see whilst we carry them out.

### Summary of works

As part of our Sea Link application for development consent, we published an Environment Statement (ES) that sets out the results of a range of detailed environmental surveys that we have undertaken in recent years. The ES also explains that there are some areas where further survey work would be required.

From August 2026, we need to undertake two sets of work. These are:

1. archaeology excavation within the land close to our proposed converter station south of Minster
2. ground investigation works to understand the locations of any potential unexploded ordnance (such as wartime bombs), and geoarchaeology surveys of the soil.

We have sought consent for these works through two separate submissions to Thanet District Council:

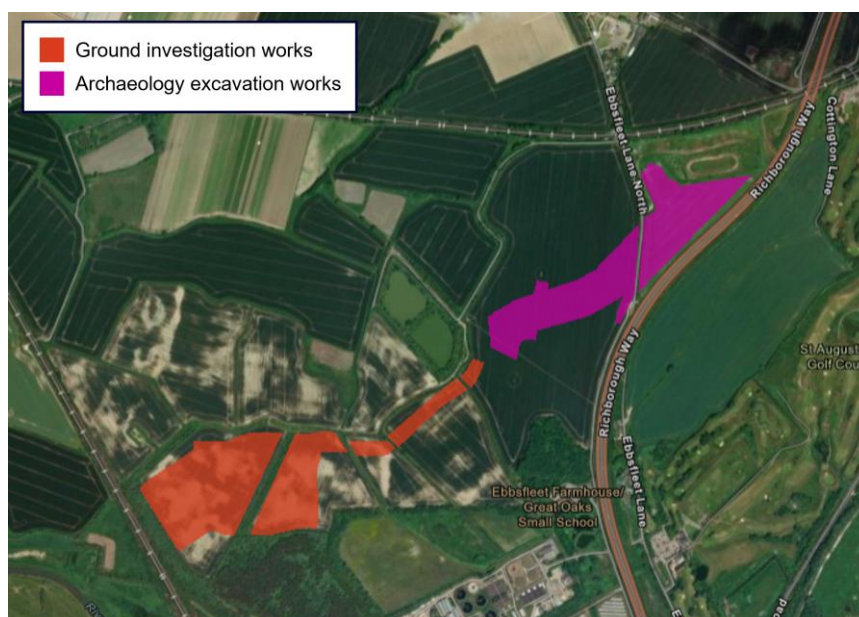
- In May 2026, we submitted a Town and Country Planning Act application (reference F/TH/26/0505) for the archaeology excavation works. This application was approved on Thursday 13 August 2026.
- In June 2026, we submitted a request for a Lawful Development Certificate (reference CD/TH/26/0647) to undertake the ground investigation and geoarchaeology works. This was granted on Tuesday 11 August 2026.

Both sets of work will begin from w/c 17 August 2026. During this time, you may see members of our team on site with diggers and other equipment and using temporary staff welfare facilities whilst the works are carried out.

**This is not the start of construction**, as the Secretary of State for Energy Security and Net Zero needs to decide on our development consent order application for Sea Link first.

### Where will the works take place?

You can see the approximate location of where we will carry out works below. Definitive maps of each set of works can be found in our submissions to Thanet District Council.

## When will the works take place?

Both the ground investigation and archaeology excavation works are due to begin from w/c 17 August 2026.

The ground investigation and geoarchaeology works are expected to take approximately 5 months to complete, weather and site conditions permitting.

We expect the archaeology work to conclude in Spring 2027. This is dependent on the quantity and significance of any archaeological finds.

Our working hours are between 7am and 7pm, Monday to Friday. Additionally, we may carry out ground investigation works on Saturdays between 7am and 5pm. No work is planned to take place on Sundays or bank holidays.

## What do these works involve?

The ground investigation works involve the use of specialist equipment to safely check the ground for any signs of potential unexploded ordnance within the land. The survey will be completed using a magnetometer probe which is hydraulically pushed into the ground to survey the soil for deep unexploded ordnance over a series of small boreholes or piles. The survey will not involve any excavation or removal of potential unexploded ordnance. The archaeology excavation works involve using a digger to remove the topsoil. You can see examples of this below. Once this is done, expert archaeologists working for us will photograph and take note of any archaeological features in the trench. Drone will also be used to identify any features in the trench.

If we find anything of significance during the archaeology works, we will work with the County Archaeologist to ensure that archaeological features have been suitably investigated and recorded. Upon completion, the trench will then be backfilled using soil that was originally excavated.

For each set of works, we will also need small areas for staff welfare and machinery storage.

## What does this mean for you?

If you live or work in the area around where these works are taking place you may notice survey equipment and machinery in use, temporary welfare facilities for our staff, as well as some low noise. You may also notice the use of drones as part of the archaeology surveys.

Most of the trenches required for the archaeology surveys are located on private land, but where Public Rights of Way pass close to our worksites we will conduct a risk assessment and implement additional safety measures, such as fencing and signage.

We are building a temporary access track between Ebbsfleet Lane North and the survey area, including three temporary bridges. This will avoid the need for vehicles travelling to and from the works to use Brooks Lane, except when building the temporary access.

We will deliver outreach activities as part of our archaeology works, working with organisations such as local schools, universities, and archaeological interest groups. These activities could include producing educational resources and holding talks with students, site visits, and volunteering opportunities, where appropriate. We will share more information about any opportunities with relevant local schools, universities, and interest groups closer to the time.
