Description of the Issue or Defect that the STCP Modification Proposal seeks to address		
There is a lack of clarity in the process for issuing an FSKN document to a prospective OFTO. NGET's current assumption is that it can only take place at takeover, but this is unclear in STCP19-5. This can cause problems for the prospective OFTO as commercial arrangements (of which the receipt of the FSKN may be part) are required to be finalised at commercial close which takes place some 8 weeks prior to takeover. In a two stage closure process the OFTO is in receipt of a licence some 7 days before asset transfer takes place. At an absolute minimum the OFTO requires the FSKN at licence grant.		
Description of the STCP Modification Proposal		
The proposal would require NGET to issue the prospective OFTO an FSKN document at the commercial close (prior to Section 8A) providing there is a clear section 1 of the ION document held by the developer of the OFTO assets (or at the point between Section 8A and Licence Grant that a clear section 1 of the ION is obtained by the Developer). Given the short timescales to licence grant, technical issues that arise after this point (that could potentially impact on the section K capability) would be dealt with through the normal STC processes once the OFTO takes over the assets. As has been established previously, Section K compliance is statement of meeting the design requirements, it is not an ongoing obligation.
