1. BSFG Action Log Review

The current version of the BSFG Action Log, including any additions from this meeting, follows this Headline Report.

2. BSFG Draft Terms of Reference:

- Chris Fox (NGET) presented the draft Terms of Reference for the BSFG, stakeholders gave their views which will be incorporated into a 2nd draft to be circulated to meeting attendees for comment prior to finalisation.
- Once finalised the BSFG Terms of Reference will be published on the JESG website.

3. TSO-TSO Model vs TSO-BSP Model

- Some stakeholders expressed concerns about the financial neutrality of the TSO in the TSO-TSO Model and asked for an update on ACER's current thinking on the models proposed in the NC FR
- Grendon Thompson (Ofgem) confirmed that the TSO-TSO Model is the foundation of the NC EB in its current form and TSO financial neutrality is paramount.

4. ENTSO-E Stakeholder Advisory Group Update

- Simon Peter Reid (Scottish Power) introduced himself as the Energy UK representative at the ENTSO-E Stakeholder Advisory Group meeting
- An overview of the pilot projects across Europe was provided and information as to where presentations could be found was shared with meeting attendees (see below²)

5. Project TERRE Update

- Stakeholders had queries about whether Project TERRE could work with the current balancing mechanism – Chris Fox (NGET) commented that this would depend on how GB implementation takes place
- An overview of the TSOs responsible for the work packages within project TERRE was given
- There were also concerns over the transparency of the CMO and questions as to whether the algorithm would be externally audited
- Similar issues related to independent auditing were raised for the CBA
- Questions were raised over who would receive inter-marginal rents in cases were the marginal price is different in an area due to congestion

6. Standard Products Update

- General question raised by stakeholders around how many balancing products currently used by NGET correlate with the current ENTSO-E list of standard products
- Some concerns related to minimum bid size were raised clarification sought on the impact of TSOs being able to define this
- The three approaches that WGAS are currently investigating for settlement of standard products were presented: block product, standardised physical product and declared physical product
- Feedback from stakeholders was received, with some concern as to the unpredictability of the imbalance costs BSPs could be exposed to if the block solution was used, as well as concerns around how the settled ramp-downs would work if consecutive bids were accepted using the physical products

 The sharing of meeting documentation was discussed and a proposal will be outlined in the draft Terms or Reference for approval by the BSFG members.

8. Next meeting

The next meeting for the BSFG will be scheduled on the 16th March from 13:00 – 16:00, the day before the next ENTSO-E Stakeholder Advisory Group. The meeting will be held at Elexon Offices in London.
