The National Grid Electricity Safety Rules make reference to specific **Approved** procedures for controlling high risk activities and the process for initiating, approving and withdrawing these procedures is outlined in this document.

3 Procedure

- 3.1 The National Grid Electricity Transmission Safety Rules makes reference to **Approved** procedures for the following activities:
 - National Safety Instructions (NSIs)
 - Restoration of Motive Power (ROMP) Procedures
 - Sanction for Work (SFW) Procedures
 - G3 Procedures
 - G4 Procedures

These procedures will be managed, and a register maintained, by the Electricity Transmission Safety Rules Team. The process will be controlled by the application of Management Procedure AMBP 228 - Management and Communication of ET Operations.
