Planning and Advanced Reservation of Capacity Agreement (PARCA) NOTICE: PARCA APPLICATION - RESERVATION OF NTS EXIT CAPACITY 7th January, 2019

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested parties.

On 10th May 2018, National Grid issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of between 40,000,000 kWh/d and 82,000,000 kWh/d in North East Yorkshire and Lincolnshire (Region 3 in the Gas Ten Year Statement¹). The indicative capacity Registration Date specified at the time was 1st January 2021.

On 7th November 2018, National Grid issued a notice ("Staythorpe Power Station ExCS Informal Notice (including exit Substitution & Baseline Revision)"). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 82,000,000 kWh/d for a capacity Registration Date of 1st January 2021.

National Grid is issuing this notice to confirm that the PARCA application has now progressed to Phase 2, and that NTS exit capacity has been reserved as follows:

From 1st January 2021 to 31st March 2023

- i) The NTS Exit Point is Staythorpe.
- ii) The quantity of Unsold Enduring Annual NTS Exit (Flat) Capacity reserved at the NTS Exit Point is 82,000,000kWh/d.
- iii) The total quantity of Reserved System Capacity reserved at the NTS Exit Point is 82,000,000kWh/d.
