Planning and Advanced Reservation of Capacity Agreement (PARCA) NOTICE: PARCA APPLICATION - RESERVATION OF NTS EXIT CAPACITY Update - 1st October 2020

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, we are issuing this notice to all interested parties.

On 6th November, 2018 we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of 2,808,000 kWh/d in Scotland and the North (Region 1 in the Gas Ten Year Statement1). The indicative capacity Registration Date specified at the time was 1st April 2020.

On 14th February, 2019 we issued a notice ("Balgray ExCS Informal Notice (including exit Substitution & Baseline Revision)"). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 2,808,000 kWh/d for a capacity Registration Date of 1st April 2020.

On 26th March, 2019 the PARCA Applicant revised the capacity requirement to 1,404,000 kWh/d and on the 15th April, 2019 we re-issued the informal notice to reflect this.

On 8th October, 2019 the PARCA Reservation Party revised the Capacity Registration Date to 1st October 2020 and we issued a notice to reflect this.

On 14th February, 2020 the PARCA Reservation Party revised the Capacity Registration Date to 1st April 2021 and we issued a notice to reflect this.

We are issuing this notice to advise that the Registration Date has been further revised following a request from the Reservation Party. Full details are as follows:

The NTS Exit Point is Balgray.

From 1st October 2021

- The quantity of Unsold Enduring Annual NTS Exit (Flat) Capacity reserved at the NTS Exit Point is 765,381 kWh/d.
- The quantity of Unsold Enduring Annual NTS Exit (Flat) Capacity reserved from each donor NTS Exit Point is as follows:
