 - Two preferred it to 0263
 - Five preferred 0263

- Raised by:
 - National Grid NTS on 07 October 2009
- Status:
 - December Modification Panel recommended implementation (10/10)

UNC Modification 0263

- Title:
 - Enabling the Assignment of a Partial Quantity of Registered NTS Exit (Flat) Capacity
- Raised by:
 - British Gas Trading on 10 July 2009
(revised 12 August 2009 and 03 September 2009)
- Status:
 - November Modification Panel recommended implementation (9/10)
 - January Modification Panel five preferred it to 0278
 - Two preferred 0278
- Next stages:
 - With Ofgem

UNC Modification 0246/A/B

- Title:
 - Quarterly NTS Entry Capacity User Commitment
- Main Features (All)
 - Requirement to put-up security prior to QSEC Auctions
 - Security remains through capacity periods
 - Liability continues for all auctions
- Unique Features
 - 0246 does not allow Parent Company Guarantees as security
 - 0246 and 246A security cover previous auctions

 - May Modification Panel did not recommend implementation (1/10)
 - One preferred it to 0246A and 0246B
